

NOMINATION PETITION INFORMATION

Election Date: Tuesday, November 3, 2020

THIS PETITION MAY NOT BE CIRCULATED OR SIGNED BEFORE August 4, 2016 AT 9:00 A.M. IT MUST BE RETURNED TO THE TOWN CLERK'S OFFICE BY 4:00 P.M. ON August 24, 2020. THE PETITION CIRCULATOR'S AFFIDAVIT AND THE ACCEPTANCE OF NOMINATION AND QUALIFICATION AFFIDAVIT MUST BE NOTARIZED. A NOTARY PUBLIC IS AVAILABLE AT TOWN HALL.

- ✍ Prior to circulating the petition, fill in the candidate information at the top of each sheet.
- ✍ Each Mayor candidate must be nominated by a petition signed by at least 10 registered electors residing within the town limits of Coal Creek from which the Mayor candidate is to be elected.
- ✍ Candidates for the office of Town Mayor or Trustee for the Town of Coal Creek, Colorado must:
 - Be a United States Citizen;
 - Be at least eighteen years of age;
 - A Registered Town of Coal Creek voter;
 - Have resided within the limits of the Town of Coal Creek for a period of at least six (6) consecutive months immediately preceding the date of the election.
- ✍ Registered electors may sign only one petition for each office for which they are eligible to vote.
- ✍ Petition signers must sign and print their legal name.
- ✍ A person may assist an elector in completing the information on the petition, if the elector is unable to print their name and address. The elector must sign their name (an X will be accepted). All required information must be filled in, either by the elector or the person assisting. The person providing assistance shall give their name, and state that assistance was given to the elector. Such statement shall be written on the petition immediately following the name of the elector or at the bottom of that page.
- ✍ Encourage registered electors to sign in ink. Make sure all required information is complete. A signer must use the address where he/she is registered to vote. A post office box will not be accepted.
- ✍ Ditto marks will not be accepted. If a correction is required, the signer should cross out the incorrect information and proceed to the next line.
- ✍ The petition circulator must personally observe every registered elector who signs his/her petition and each signer must state to the circulator that he/she is a registered elector of the Town of Coal Creek.
- ✍ Do not take a petition apart. [You cannot add sheets to this petition. If you would like to gather more signatures, ask for another petition.] Evidence of disassembly will disqualify the entire petition section.
- ✍ Submit all petitions at the same time.
- ✍ Fair Campaign Practices Act: In accordance with the Colorado Fair Campaign Practices Act (C.R.S. 1-45-101, et,seq.) all candidates for a municipal office must file a candidate affidavit and other reports. Information regarding filing deadlines may be obtained at the Municipal Clerk's office at the Town of Coal Creek, Colorado. For candidate committee reporting, please consult the Fair Campaign Practices Act Manual.
